209 S Market-Burress for roof mounted solar panels. A motion was made by Councilmember Maddox and seconded by Councilmember Summers to approve the installation of the roof mounted solar panels. Motion passed by unanimous voice vote.

NEW BUSINESS:

Town Park upgrade- Mayor Glanden suggested the need for additional playground equipment for the Frederica Park at a cost of \$5000. All agreed that the Park is really well used and the additional equipment is needed. A motion was made by Councilmember Maddox and seconded by Councilmember Simpler to approve the \$5000.00 purchase of the additional equipment. Motion passed by unanimous voice vote.

Gobble wobble- Anita Hart asked the Town to once again be a sponsor for the Lake Forest School District Gobble Wobble event on November 21st, 2021. With the requested \$500 sponsorship the Town would get 4 entries and logo would be on advertisement and T-shirts. A motion was made by Councilmember Maddox and seconded by Councilmember Simpler to approve the \$500 sponsorship of the Gobble Wobble event. Motion passed by unanimous voice vote.

Anita Hart also said that the Farmers Market had a great first year thanks to all the volunteers and staff that helped. The vendors reported earnings of \$17,500.00 and had up to 180 visitors a day from June 6th to Sept. 5th. She also reported that they will be having a fall Farmers Market on Oct 10th and 17th with Pumpkin painting for the kids. Council all thanked her for a great job well done.
