WATER DEPT. / TREASURER'S / POLICE / CODE ENF. REPORT:

CODE / WATER REPORT: Dustan Russum reported that the sidewalk project is still active and is planned to go from the firehouse to the Senior Center. The Water St. tower painting is progressing and when completed they will start on the Fifth St water tower coating. He also reported that they have towed some cars, worked on Frog Leg Ln and reported that the Front St water main project is completed and final walk through will be soon.
