MUNICIPAL ELECTION TO BE HELD

SATURDAY, MARCH 4, 2023

FROM 12 NOON UNTIL 5:00 PM

POSITIONS OPEN:

Three Council seats with a term of two (2) years

Letters of Intent must be turned into the Council starting December 5, 2022 and no later than 4:00 PM January 27, 2023.

Town Hall will be open late on January 18, 2023 until 8:00 PM.

Certification of Intention must be filled out online at <https://elections.delaware.gov/pubs/index.shtml> and a copy submitted with the letter of intent to the Town of Frederica.

Eligibility Requirements:

1. 18 years of age or older by the date of the election.
2. Citizen of the State of Delaware.
3. Resident of Town of Frederica for at least 1 year prior to the election.
4. Cannot be convicted of a felony.

Absentee Ballots will be available after January 27th upon request and must be turned into Town Hall no later than March 3, 2023 by Noon.

To vote in the municipal election, you must register in person at Town Hall on or before February 2, 2023.

Rental License.
