A RESOLUTION ADOPTING A LIST OF OTHER DEBTS OWED TO THE TOWN OF FREDERICA TO BE ADDED TO TAX BILLS AND SETTING FORTH THE PROCEURE FOR APPEALS.

WHEREAS, \S 16 of the Charter of the Town of Frederica permits any and all charges, costs, or other assessment owed to the Town to be added to the tax bills; and

WHEREAS, Town staff has prepared the list of charges, costs, and other assessments attached hereto.

NOW, THEREFORE, BE IT RESOLVED that the list of charges, costs, and other assessments attached hereto are hereby adopted; and

BE IT FURTHER RESOLVED that the Town Manager shall cause the charges, costs, and other assessments shown on the said list to be added to the tax bills of the appropriate properties; and

BE IT FURTHER RESOLVED that said list shall be made available for public inspection at the Frederica Town Hall, 2 West David Street, for at least ten (10) days; and

BE IT FURTHER RESOLVED that the Frederica Town Council will hear appeals from charges, costs, and other assessments shown on said list and to make such corrections and revisions as it deems appropriate on July 17, 2024 at 7:00 PM; and

BE IT FURTHER RESOLVED that not less than ten (10) days prior to the date of the meeting of the Town Council of Frederica, the Town Clerk shall post a notice in Frederica Town Hall, 2 West David Street, attached to said list and shall post copies of the notice in two (2) or more public places in the Town of Frederica and in a newspaper of general circulation in the Town of Frederica advertising to all concerned the date and place where said list has been made available and that the Town Council of Frederica will hear appeals from charges, costs, and other assessments shown on the said list and to make such corrections and revisions as it deems appropriate; and

BE IT FURTHER RESOLVED that any person or entity desiring to contest any charge, cost, or assessment shown on the attached list shall file a Notice of Intent to Appeal at least three (3) days prior to the hearing, such notice shall describe the factual and legal basis for the appeal, and he/she shall attend the Town of Frederica Council meeting on July 17, 2024 at 7:00 PM.
