## **PUBLIC HEARING NOTICE**

In accordance with the Frederica Zoning Ordinance and Chapter 3, Title 22 of the Delaware Code, the **Board of Adjustment** of the Town of Frederica will hold a **Public Hearing in the Frederica Town Hall, 2 W. David Street, on Thursday, February 5, 2026 at 6:30PM**

The purpose of the hearing is to consider the following variance applications from Michael S. Koppenhaver relating to signage at the proposed 7-Eleven site.

### **MAP # 5-08-141.00-01-08.00/00001**

1. Wall-mounted signs exceeding the maximum permitted area of 24 square feet
2. More than three wall-mounted signs when all wall-mounted signage (A and E signs combined) is considered.
3. A fuel canopy sign exceeding the maximum permitted wall sign area of 24 square feet
4. A pylon sign exceeding the maximum permitted area and height for free-standing signs.
5. One additional directional ground-mounted sign beyond the maximum permitted quantity.
6. One illuminated monument sign (M) located near the site entrance. The proposed monument sign measures 11.61 feet by 6 feet, for a total sign area of approximately 69.7 square feet, and has an overall height of 15 feet.
